This fee covers the cost of annual cleaning and basic maintenance of the instrument. If there is damage to the instrument beyond what is normal wear and tear, by negligence or abuse, the undersigned is agreeing to pay for all repairs or replacement as needed. Only the principal or district designee will be able to assess whether an instrument needs to be repaired or replaced due to negligence or abuse. The undersigned are responsible for all necessary repairs and maintenance while the instrument is under their care.
